# PLANNING APPLICATIONS

*Cllr. Hart left the room during the discussion of this application.* 

**PA15/09478** – Two storey side extension and single storey front and rear extensions and form new access onto road. St Edwards, Chursh Hill, Tintagel PL34 oDL. Mr A. Nelson.

It was proposed by Cllr. Goward, seconded by Cllr. Dorman and RESOLVED that the original objections to this application still stand. i.e. overdevelopment, differing roof lines, and these would be visible from the village. All in favour. Carried.

Also to consider any other applications received since the Agenda was published.

**PA16/01345** – Installation of an additional 0.3m microwave dish on the existing monopole structure. Trecarne Rustic Stone Quarry, access to Trecarne Farm, Trebarwith, Delabole.

It was proposed by Cllr Hodge, seconded by Cllr. Goward and RESOLVED that no objection be made to this application. All in favour. Carried.

#### AGENDA ITEMS

**Public conveniences at Trebarwith and Trevena Square:** It was proposed by Cllr. Hart, seconded by Cllr. Soutter and RESOLVED that the clerk would ask the solicitor to acquire clarification with regard to item 3.3(a) on the tenancy agreements. Five in favour, two against. Carried.

#### Social Hall 2014/15 accounts and AGM Minutes: Noted.

**Social Hall repairs and storage for Christmas lights**: It was proposed by Cllr. Hart, seconded by Cllr. Dorman that a survey quote would be obtained for the Social Hall. All in favour. Carried. The clerk was asked to get quotes for a new storage shed.

**Paperless Plans:** It was proposed by Cllr. Wickett, seconded by Cllr. Dorman and RESOLVED that the clerk would forward planning references to councillors via email before the meeting, and plans would be looked at on the projector before the meeting. All in favour. Carried.

**Trevena Square Lighting:** It was proposed by Cllr. Wickett, seconded by Cllr. Soutter the clerk would speak to Nick Spurden as there may be a lantern top which was put into storage which may be possible to restore for use in Trevena Square. Clerk will report back on the suitability of this at the next meeting. All in favour. Carried.

**Deposit account options:** It was proposed by Cllr. Soutter, seconded by Cllr. Wickett and RESOLVED that half of the deposit account monies would be placed in a fixed term account and the other half in a 32-day notice account. All in favour. Carried.
