Minutes of the Meeting of Tintagel Parish Council
Wednesday 3<sup>rd</sup> February, 2016 at 7.00 p.m.

Nine members of the public were present.

## Invitation to members of the public to speak prior to meeting regarding items on the Agenda (10 minutes allowed for this item)

Several members of the public spoke to place objections with regard to planning application PA15/11183. These were on the grounds of over-development of a small site, the twenty-one metre ruling not being observed, daylight and privacy to surrounding properties being affected, and danger to the public caused by too much traffic using a drive with poor visibility to Fore Street.

Mr. Curtis enquired if a viability study would be in hand for the Social Hall before any expenditure.

#### **REPORTS**

**CCC C/Cllr. Brown:** Cllr. Brown reported for the next five years, five thousand new houses per year would be built. Poole and Bodmin will be the main areas. Houses will be affordable builds, both to rent and buy. The County Council are concerned that not enough people register to vote, at present 30,000 residents are not registered.

Cllr Brown informed the council that South West Water will be laying a new pipe line which could cause traffic problems for some time.

It was noted that the County Council boundary review will now not take place until the 2020/21 elections.

PA16/00444 - Alterations to external seating areas and external hard landscape.

New window in west elevation and new lean-to to link on back elevation .

**Trevena Square repairs and lighting -** Cllr Wickett reported that the small area of gravel will be replaced with slate for health and safety reasons. The clerk will arrange for the seats to be re-coated with preservative. The clerk was requested to look at lighting alternatives for the seat lighting.

**The Social Hall, repairs needed:** Cllr Flower will report on any issues following the Social Hall AGM next month.

**Storage for Christmas lights:** Cllr. Flower will advise on this following the Social Hall AGM next month.

A Tree preservation order for a tree in the garden of Gordon House, Tintagel has been received, noted and filed.

An email from Mr Harding regarding parking at Trebarwith Strand complained about a fine received despite paying the fee. However, no parking ticket was issued, although this was reported, Mr Harding still had to pay the fine. The clerk has received other complaints with similar issues relating to this car park.
